6. Bid shall be opened in the presence of Bidders representatives who choose to attend on 3-12-2019 13:00 hours at the office of Dhurkot Rural Municipality Barbot Gulmi Nepal.
Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum as mentioned above in table, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[0910501307701002] Dhurkot Ga.Pa. Dharauti Khata at [Sunrise Bank Ltd. , Gairidhara Crossing Kathmandu ,Kathmandu, Kathmandu] and submit the receipt of the deposited amount of cash along with the Bid Document.

10. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 with amendment and Public Procurement Regulation-2064 with amendment and other prevailing regulations
